# Capacity Building, Movement, & Networks Initiatives support

community-based organizations in providing culturally specific resources that address the emergent needs of survivors and promote strategic partnership development and collaboration; provide training & technical assistance to grantees surrounding traumainformed work, providing help in developing programs and supporting organizations' sustainable growth, drawing from the lived experiences of survivors and the larger AA and NHPI-serving community; support advocates, survivors, policy makers, funders, social service providers, state coalitions. other resource centers, and mainstream organizations to address the impact of genderbased violence in AA and NHPI communities.



#### Language Access Center

trains advocates, judges, attorneys, sign/spoken language interpreters, law enforcement, social service providers, state coalitions, and administrators on the development, compliance, and implementation of language access plans; and interpreting for domestic violence, sexual assault, and trafficking victims with limited English proficiency.



Research & Evaluation analyzes critical issues/trends in gender-based violence within the AA and NHPI communities; develops cutting-edge reports and resources; conducts needs assessments, curates, and disseminates data and findings, including disaggregated data; provides training and technical assistance on monitoring and evaluation; conducts community based participatory research and more.




#### Policy & Legislative Advocacy

# 2023 PEER-TO-PEER NATIONAL ARP CONVENING

API-GBV, in partnership with culturally-specific resource centers Ujima, Esperanza United, the National Organization of Sisters of Color Ending Sexual Assault (SCESA), Mujeres Unidas, the National Organization of Asians and Pacific Islanders Ending Sexual Violence (NAPIESV), the Alaska Native Women's Resource Center, and National Indigenous Women's Resource Center, convened the first national peer-to-peer convening for American Rescue Plan subgrantees in October 2023 in Washington, DC. More than 400 attendees from culturally-specific survivor-serving organizations across the country participated in two days of plenaries, workshops, networking, and other activities to deepen connection with peers, learn about emerging trends and strategies, and honor culturallyspecific advodacy. Featuring a cultural reception and several cultural performances, the Convening was designed with intentionality to not only be an opportunity to learn, but also to be a celebration of culture and community.

Staff across different API-GBV programs had the chance to meet and connect with local advocates and hear about their work in their communities. Planning the Convening on a shortened timeline and in partnership with so many other organizations taught us valuable lessons in collaboration. Like subgrantees, API-GBV staff felt energized and reconnected to our goal to build and sustain culturally-specific supports for survivors of violence.

I came away feeling validated about the anti-racist, decolonizing, solidarity-minded being that I am. What a relief to not have to police my language, to celebrate who we are and be humbled about what I DON'T know about other groups who are being targeted.

### API-GBV STRATEGIC PLANNING RETREAT
